# **Bidders Exceptions and Clarifications**

### AMERICAN WIRE GROUP

- Bid American Wire Group, Kalas Wire, Nexan, Nehring, Alumoclad Mexico, (Not an FMPA approved manufacturer, but may be awarded at your city's discretion- currently used by Lee County Coop), Kris Tech Wire (Not an FMPA approved manufacturer, but may be awarded at your city's discretion currently used by JEA).
- Lead time is 7 to 70 days, depending on the item.
- Nehring orders are freight allowed on 5000lb shipments to one location. Longest lead time will dictate ship date on mixed orders for freight allowed.
- All Nehring items are subject to price adjustment at time of shipment; this is an exception to FMPA's Terms & Conditions. FMPA recommends that Nehring be rejected for that reason – However acceptance can be made at utility's discretion.

### ANIXTER (Formerly HD Supply)

- Bid Nehring, Colonial Wire, BICC (General Cable), Conex (Not an FMPA approved manufacturer, but may be awarded at your city's discretion currently used by OUC, JEA, Lakeland, Leesburg, Vero Bch) and LS Cable (Not an FMPA approved manufacturer, but may be awarded at your city's discretion currently used by KUA, Ocala, New Smyrna Bch).
- Lead time is 21 to 168 days, depending on the item.
- Minimum Order Amount applies; please see the tab sheet for details.
- Nehring orders are freight allowed on 5000lb shipments to one location. Longest lead time will dictate ship date on mixed orders for freight allowed.
- All Nehring items are subject to price adjustment at time of shipment; this is an exception to FMPA's Terms & Conditions. FMPA recommends that Nehring be rejected for that reason – However acceptance can be made at utility's discretion.

#### **IRBY UTILITIES**

- Bid Okonite and CME
- Lead time is 56 110 days, depending on the item and manufacturer.
